CLASS RECALCULATION OF ATTORNEYS' FEES

(City of Cincinnati Pension Litigation)

This matter came before the Court on the Notice of Retiree Plaintiffs and the Retiree Class' Notice of Recalculation of Attorneys' Fees (Doc. 139). The notice was submitted pursuant to the Opinion and Order issued by this Court on September 9, 2020 (Doc. 138). Based on that Order, the Retiree Plaintiff have adjusted their request for fees previously submitted in Docs. 134 and 137.

In the Motion of Retiree Plaintiffs and the Retirees Class for Award of Attorneys' Fees (Doc. 134), the Retiree Class sought \$77,501 in attorneys' fees for legal services provided from April 2019 through November 30, 2019. Based on the Opinion and Order of this Court (Doc. 138), the Retiree Plaintiffs and Retiree Class submitted an adjusted award amount of \$73,973.00 in attorneys' fees for legal services provided from April 2019 through November 2019.

The Supplemental Affidavit of Peter J. O'Shea in Support of the Motion of Retiree Plaintiffs and the Retiree Class for Award of Attorneys' Fees (Doc. 137) requested legal fees from December 1, 2019 through April 30, 2020, in the amount of \$22,277.50. Based on the Opinion and Order of this Court (Doc. 138), the Retiree Plaintiffs and Retiree Class have

submitted an adjusted amount of \$22,026.50 in attorneys' fees for legal services provide from

December 1, 2019 through April 30, 2020.

Based on the foregoing and the Court's September 9, 2020 Order (Doc. 138), it is hereby

**ORDERED** that:

1. Retiree Plaintiffs' Motion for Attorney Fees (Doc. 118) is **GRANTED** and Retiree

Plaintiffs are awarded \$35,307.50 in attorneys' fees.

2. Retiree Plaintiffs' Motion for Attorney Fees (Doc. 129) is GRANTED and Retiree

Plaintiffs are awarded \$10,043.00 in attorneys' fees.

3. Retiree Plaintiffs' Motion for Attorney Fees (Docs. 134 and 137) is **GRANTED** 

subject to Retiree Plaintiffs' Notice of Recalculation (Doc. 139) and Retiree Plaintiffs

are awarded \$95,999.50 in attorneys' fees.

4. The City shall pay the amounts awarded within 30 days of this Order.
